## INITIAL ALARM REGISTRATION

All alarms must be registered with the Borough for the proper personnel to be contacted during an emergency. The attached registration form is to be completed and returned to this department.

Accordingly, pursuant to Borough Ordinance #1567, Section 1;80-12, Installation of alarm device or local alarm; fee; inspections; existing devices; an alarm registration fee of \$25.00 shall accompany each initial application.

Pursuant to Borough Ordinance #1567, Section 2; 80-24, Application Fee; an **annual** administrative charge of \$10.00 shall be charged to each owner of an alarm. The total cost of the registration fee and administrative fee will be **\$35.00. Please make checks payable to the Palisades Park Police Department.**

Be advised. After three (3) false alarms in the same calendar year there will be an assessed fine of \$50.00 per alarm. After the sixth (6) false alarm in one calendar year, each subsequent false alarm will be subject to a fine of \$100.00
